

CURRICULUM VITAE

After degree I coordinated the School of Social Care Professionals of Trento for four years (1994-1998) and headed the research sector of Istituto Regionale di Studi e Ricerca Sociale (Regional Institute for Studies and Social Research – now Fondazione Franco Demarchi in Trento), where I was in charge of managing the education of social workers (both for public and no-profit sector) and conducted research on youth, elderly people, social worker and organizational processes.

After, I worked as a consultant and freelance researcher focusing on organizational innovation and corporate social responsibility. Then I re-entered the university and enrolled in a PhD program in "Information Systems and Organization" in the Faculty of Sociology of Trento, gaining a PhD in 2006.

In 2006 I obtained a three years post-doctoral grant at the Department of Sociology and Social Research of Trento as part of an European research program on gender segregation in organizations (EQUAL Gelso - Gender, Work, Occupational Segregation), with a special focus on the analysis of non-parity costs; after I held a five years grant (2008-2013) in a research program aimed at designing an electronic health record to be used by citizens (<https://trec.trentinosalute.net/ricerca>).

This work has characterised the last phase of my academic experience. I have been in charge as principal investigator of this five years program as evaluator of a regional Personal Health Record. Using both quantitative and qualitative methods, I have explored, population behaviour, patient practices, and any need still uncovered.

My actual research focuses on the consequences of the implementation of new technologies in organizational settings, with special attention to the field of medical informatics and cyber warfare. Other research interests have been youth, social services organizations, Corporate Social Responsibility, temporary workers and research methodology, sociology of religion.

I held courses of "Business organization" and "Sociology of organization" in several universities like University of L'Aquila, University of Siena, University of Verona and University of Milano-Brescia and University of Trento. Now I am teaching sociology at the Medicine and Nursing Department University of Verona.
